Assessment Review Board

There are three seats on the Board of Assessment Review. Currently, the board of review consists of Chairman Donna Brown, and members Rich Weaver, and Candy Brown. The Board of Assessment Review holds Grievance Day on the fourth Tuesday of May from 4:00 P.M. to 8:00 P.M. at the Fowler Town Hall.

Residents who disagree with their assessment are urged to meet with the Town Assessors to discuss their assessments **PRIOR** to presenting their grievance to the Board of Assessment Review. To make arrangements to meet with an assessor at the Town Hall, please call the **Assessor's Office at 315-287-0045 Ext 102 or email assessor@fowlerny.gov.**

After meeting with the assessors' residents, who still wish to grieve their assessments may do so at the date and time previously outlined. The Board will review grievances and then decide to either lower the property owner's assessment or leave the assessment the same. Residents who have filed a grievance are notified of the outcome by U.S. Mail.

Justice Department

Tim Knowlton is the Town Justice for the Town of Fowler. Court is held on the 1st and 3rd Tuesday of every month at 12:00 PM upstairs in the Fowler Town Hall. Fines may be paid at your court appearance or sent in the mail. Individuals who wish to make payments to Fowler Town Court using credit and debit cards may do so through **allpaid.com**. Go to www.allpaid.com and use the Pay Location Code (**PLC a0026f**). The Court does not accept checks. Irma Ashley, Court Clerk, is at the Town Hall on Mon. Tues. and Wed. from 9:00 AM to 3:00PM to answer questions and collect fines. Town Board

Sylvia Lake Public Beach 29 Old Beach Road, Gouverneur NY 13642

The Public Beach is owned and operated by the Town of Fowler with guidance from the NYS Board of Health (Canton Office). The beach is open seven days a week from the end of June to the end of August. Certified lifeguards are on duty during the posted hours of operations. (10:30 a.m. to 7:30 p.m.) Handicapped and public parking is in relative proximity to the beach entrance.

The beach has a picnic area with tables and charcoal grills for public use.

Change rooms, a drinking fountain, rest rooms, and a handwashing station are also on site.

We have a great group of lifeguards led by Claire Knowlton, who met the needs of all who visited the beach in 2025.

The Village of Gouverneur Recreation Department is a mainstay at four days a week as the Sylvia Lake beach continues to provide supervised fun and exercise to local children and adults alike. Historian's Office

If you are researching ancestors and/or working on your family genealogy, contact my office as I have some records on hand that may assist you in your search.

I was able to confirm 28 names of people from the Town of Fowler who were in the Korean Conflict, and had their names engraved on a plaque. The plaque is hanging in our Town Hall alongside the existing plaques from the Civil War, World War I, and World War II.

The Town of Fowler maintains 56.25 Miles of Town Roads. In the winter months the town plows 73.75 miles of roads which includes County Route 22 and County Route 24.

We appreciate everyone's patience this past year during our busy 2025 construction season. We have been steadily working on my goal of upgrading the Town roads and equipment.

In early 2025 the Town ordered a new 2026 Mack Plow Truck, which was delivered in October, and is waiting for Viking to accessorize it with plows and a box. The new Mack Plow Truck will be finished and ready to use in 2026.

In 2025 we rebuilt 2.1 miles of the Country Club Road, resurfaced the last portion of Sylvia Lake Road, and 1.1 miles of the Doane Road. The highway crew replaced 15 culverts on the outer portion of the Country Club Road and cut numerous miles of shoulders.

In 2026 we are planning to repave the Chub Lake Road and rebuild 2.1 miles of the Country Club Road, as well as prepare the roads for our planned 2027 projects.

I would like to thank everyone for their support this year. It is your support that makes this team so successful.

Dog Control (315) 528-7988

There is a leash law in the Town of Fowler. There is also a law stating that **ALL** dogs 4 months of age or older must have a rabies shot and be licensed in the Town in which they live. If your dog is not micro-chipped, it would be helpful to put your name and phone number on your dog's collar, so it can be returned to you if it is found.

The rabies clinic in 2025 was a big success. Watch for our free rabies clinic in August of 2026.

The Department of Agriculture & Markets mandated new rules and regulations for all dog kennels going into effect in January, 2026,

Ethics Board

The Fowler Board of Ethics Committee consists of five members, Chair Alex Mackinnon, Marcia Cleveland, Vicky Cappellino, Vivian Goodman, and Leo Knight Jr. Each member serves a four -year term. Any person may file a concern or complaint in writing to the chairperson who in turn will set up a meeting with the other committee members to address the issue. The committee may request an interview with the party or parties involved to discuss the situation further to reach a decision or solution. After the discussion, the committee notifies the party or parties of their decision in writing. There were no complaints in 2025.

VETERANS:

If you are a **Veteran or surviving spouse** of a Veteran with an **honorable discharge** you may be eligible for one of the following exemptions:

Alternative Veterans Exemption (form RP-458-a) available only on residential property of a veteran who has served during a designated time of war or received an expeditionary medal.

Cold War Exemption (form RP-458-b) available only on residential property of a veteran who served during the Cold War period.

You must apply prior to March 1, 2025 for the 2025-2026 Assessment Roll. Please call our office at **(315) 287-0045 Ext 102** and we will mail you the necessary application to complete and return with necessary documents. STAR EXEMPTION INFORMATION:

If you are currently receiving the basic or enhanced star exemptions NYS Tax department will be doing the yearly qualification for these exemptions. If more information is needed, you will receive an information request in the mail directly from the NYS Tax Department office. If you have questions or need assistance, please feel free to call our office and we will try to help you all we can.

If you currently have the **BASIC Star Exemption** and **at least one** of the homeowners **turns 65 before December 31, 2026**, you can still apply for the Enhanced Star Exemption. **The income limit for the Enhanced Star Exemption is \$110,750 or less.** If you qualify you will be able to continue to receive the **exemption** on your 2026 school tax bill.

HOW TO APPLY FOR ENHANCED STAR

*****You can apply for Enhanced Star on the Homeowner Benefit Portal www.tax.ny.gov/star. If you do not have computer access, you can call (518) 457-2036 to register.*****

NEW HOMEOWNERS ARE NOT ELIGIBLE FOR THE BASIC OR ENHANCED STAR EXEMPTION CREDIT ON TAX BILL. NEW HOMEOWNERS MUST APPLY FOR STAR CREDIT WITH NYS TAX DEPARTMENT. WITH STAR CREDIT YOU RECEIVE A CHECK FROM THE TAX DEPARTMENT TO APPLY TO YOUR SCHOOL TAXES. **You can apply for Star Credit (WHICH WILL BE A CHECK), by calling 518-457-2036 8:30am to 4:30pm or online 24 hours a day, 7 days a week at www.tax.ny.gov/star This number is a good number to call with any questions on STAR CREDIT.**

Senior Exemption is eligible for seniors 65 or older upon age, ownership & income qualification. You must earn below \$30,700 per year to qualify for this. **If you believe you qualify, please contact your local assessor at 315-287-0045 Extension 102** and we will mail you the necessary application for this exemption.

HOMEOWNERS TAX REBATE CREDIT OR CHECK QUESTIONS CALL 518-453-8146.

Our office is currently working on updating property record cards for the Town of Fowler as mandated by NYS Office of Real Property. Data Collection is needed to value each parcel of property located within a specific assessing jurisdiction. It is very important that the data be recorded as accurately and consistently as possible as it will serve as the basis of all future appraisal activity in revaluation programs and ORPS market survey process. Not only will this information provide the specific elements needed to value each parcel of property, but it will also become a valuable record of information for future use by the assessor's office. If the data collector comes to your property and no one is home a notice will be left so you know we were there. If you could please call the phone number left on the notice that would be greatly appreciated. We might be able to confirm any information needed over the phone and can set up a time when it would be best to return to your property. This is a work in progress, and your help would be greatly appreciated.

Town Planning Board

The Planning Board consists of five Fowler residents. Currently, there are four members: Chair Stephen Gale, Dan Kingsley, Roger Refici, and Vicky Cappellino, with the 5th member to be appointed in January of 2026 to replace newly elected Town Councilmember John Walsh's seat on the planning board. There are no zoning laws in the Town of Fowler.

The Planning Board makes its decisions and submits them to the Town Board according to the Town's Land Use Law. You may view a hard copy of the Land Use Law at the Town Clerk's Office. Or you may view or print the Land Use Law from our website: www.fowlerny.gov .

Planning Board meetings are held, when necessary, in the Fowler Town Hall. Meetings are advertised in the local newspaper and on the Town of Fowler website.

Code Enforcement Officer codeofficer@fowlerny.gov

Building permits are required for demolition of buildings, renovations, structural changes on your home or buildings, roof replacement, pools, buildings over 144 sq. ft, and septic systems.

Building and use permits are still required for any construction to enlarge, repair, move, demolish or change the occupancy of any building or structure as well as changing or installing any electrical, gas, mechanical or plumbing system.

Effective January 1, 2021, Building Permit applications and fee schedules were updated, to be more compatible with surrounding Towns. Building Permits and Fees can be viewed and downloaded from the Town website: www.fowlerny.gov . It is the responsibility of the **homeowner or contractor** to fill out the building permit and call Code Enforcement Officer **Glen Besaw, at 315-323-0761** with any and all questions pertaining to a building permit before it is turned in to the Town Clerk's office with payment.

If residents or contractors have any questions, they need to call **Glen Besaw, Town of Fowler Code Enforcement Officer at 315-323-0761**. Glen will make every effort to get any requested information as quickly as possible, which will prevent the possibility of any work stoppage or delay.

ANY PERSON STARTING WORK WITHOUT A BUILDING PERMIT WILL BE CHARGED AN ADDED FEE OF \$50.00 NO EXCEPTIONS.

Regular Office hours are Monday thru Friday, from 9:00 AM to 12:00 PM and 1:00 PM to 4:00 PM. This office issues dog licenses, hunting and fishing licenses, marriage licenses, One Day Marriage Officiant Licenses, Death Certificates, Certified Marriage transcripts, Genealogical Service Requests, and disabled parking permits. Voter registration forms, absentee ballot applications and building permit applications are available at this office. Notary service is also available at the Town Clerk's Office. We will start collecting land taxes on January 2, 2026. Taxes

may be paid with cash, check, money order, and credit /debit cards. There is a 2.65% fee added if paying by credit/debit cards. Payments may be received after hours by using the drop-box located at the rear entrance of the Town Hall.
