Assessment Review Board

There are three seats on the Board of Assessment Review. Currently, the Chairman seat is vacant. Other members are George Erdman Jr., and Donna Brown. The Board of Assessment Review meets once a year on the fourth Tuesday of May from 4:00 P.M. to 8:00 P.M. at the Fowler Town Hall.

Residents who have tax grievances are urged to meet with the Town Assessors to discuss their issues PRIOR to presenting their claims to the Board of Assessment Review. To make arrangements to meet with an assessor at the Town Hall, please call the Assessors at the phone number listed on Page 1 or call the Town Clerk at 315-287-0045.

If residents wish to grieve their assessments, they may do so at the date and time previously outlined. The Board will review grievances and then make a decision to either lower the griever's assessment or let it stand. Residents who have appeared are notified of the outcome by U.S. Mail.

Town Clerk and Tax Collector

The Town Clerk and Tax Collector Office is open from 9:00 AM to 12:00 PM and 1:00 PM to 4:00 PM Monday through Friday. This office issues dog licenses, hunting licenses, disabled permits, has voter registration forms, absentee ballots, building permit applications and Star Program forms available for the public.

The Tax Collector started collecting taxes on January 4, 2016. If you have any questions feel free to call the Town Office at 315-287-0045.

NOTE: There is a convenient Drop Box at Town Hall. It is checked twice a day on business days.



Assessor's Office

If you have bought or built a new home in the Town of Fowler in the past few years and **do not** have a Star Exemption on the home, you may be eligible for the Star Exemption.



To determine if you are eligible, procure a Star Application Form from one of your Assessors or the Town Clerk's Office. Residents who have the BASIC STAR have got to contact the State to re-register for the star even if they have filled out a Star form with the Assessors Department this year.

The function of this board is to receive and consider Building Permits which the Code Enforcement Officer has denied when some aspect of the construction does not comply with the Local Building Codes. After examination of the site and review of the submitted plans, the Board considers, discusses, and then either grants or denies the Building Permit.

The Board meets only when necessary at 7 PM in the Fowler Town Hall. Meetings are advertised and all interested persons are invited to attend.

Town Planning Board

The Planning Board is made up of six Fowler residents. The members are Chairman, Rick Whitford, Jeff Andrews, James Besaw, Ed Siebels, Andrew Miller and Stephen Gale. The purpose of the Planning Board is to recommend appropriate land use that will be to the betterment of the Town and submit their recommendations to the Town Board. They also review Building Permits and do special projects that the Town Board assigns.

The Planning Board meets the last Tuesday of the month as needed, as well as other times when necessary at 7:00 PM in the Fowler Town Hall. Meetings are advertised in the local paper and on the Town of Fowler website. All interested persons are welcome to attend.

The Town Board adopted the "Town of Fowler Land Use Site Plan Review and Subdivision Local Law" (December 6, 2014.) Code Enforcement Office

Fowler has had another busy and growing year with 86 Building Permits issued. Code Enforcement Officer Rick Whitford would like to thank everyone for their cooperation and patience.



Building permits are required for any structure 144 sq. ft. and over, any structural changes on your home or buildings, and for all roofing projects. If anyone has any questions, call Rick Whitford at 315-286-2360 or call the Town Clerk's Office at 315-287-0045.

Fowler is also trying to address the Maintenance and Junk Laws for the safety and health of our residents. We would like to ask your help in maintaining your property free of trash and junk cars.

The Property Maintenance Code of NYS/Sec.303 (F) requires premises identification and that buildings shall have approved address numbers placed in a position to be plainly legible and visible from the street or roadfronting the property. Numbers should be 4 inches tall.

Fowler Dog Control

This year has seen its share of complaints, lost dogs and dog bites. Again we would like to stress that there are dog laws in the Town of Fowler. Also, dogs 4 months of age or older must have a rabies shot and be licensed in N.Y.S. Our number is 315-528-7988.

The town has worked closely in 2015 with the St. Lawrence Co. Housing Authority. (www.nocohousing.org) Fowler housing rehabilitation using the grant monies from the Community Development Block Grant (CDBG) will complete the rehabilitation of fourteen more homes in Fowler in the upcoming year 2016. The town is currently looking for applicants for a third grant application for another round of funding to be started in 2017. Residents can contact the Town Clerk office for an application.

Highway Department

The Town maintains 56.25 miles of roads.

In the winter months the town maintains 73.74 miles of road including 17.49 miles of county roads.

The summer of 2015 saw the completion of the paving project on the Chub Lake Rd. It included approximately three miles of new hot mix surface and new shoulders.

We are planning to repave 3-4 miles of town highway in the upcoming year.

We appreciate your patience during the construction season and ask everyone to drive slowly as they pass through the construction zones.



The highway department saw a change in leadership as Randy Durham replaced Michael Sweeney as a result of the November election. Randy will oversee the highway operations for the next four years beginning on January 1st, 2016.

The upstairs in the Town Hall is available for use by Fowler residents. Arrangements to use the Hall may be made by calling Karen Simmons at 315-287-4753.

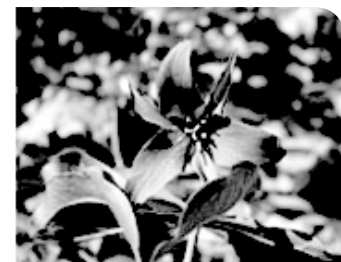
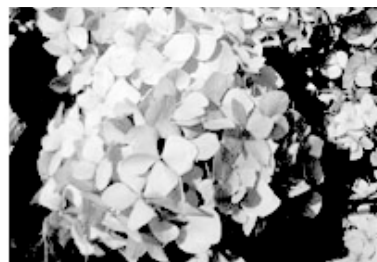
